

## 2 Introduction

---

### 2.1 Purpose of the Document

This document sets out the Data Requirements for the Migration Control Centre (MCC) and the Migration Planning Management Tool (MPMT).

This document outlines the Data Requirements for the Migration Control Centre (MCC) and the Migration Planning Management Tool (MPMT), as well as providing a view of the external Migration Report Catalogue.

It seeks to ensure that the MCC and Industry Stakeholders have the necessary data and reporting capabilities to monitor, manage, and control the MHHS migration effectively.

This document, and supporting documents as listed in the References section, together with the migration timetable, form the MHHS Migration Plan that details the obligations, as defined in Section C12 of the Balancing and Settlement Code Section C, that defines the obligations on MHHS Market Participants relating to participation in the Migration of MHHS Metering Systems.

Refer to the REF-18 MHHS-DEL2952 - Supplier Envelope and Plan Submission Guide v3.1 for information on how the MCC will seek support Report delivery with Participants.

### 2.2 Overview

#### 2.2.1 Data Requirements

The Data Requirements section aims to:

- Identify key data sources and reports that will serve as inputs for the MCC and MPMT.
- Ensure the accuracy and completeness of reference data used by the MCC and MPMT.
- Understand additional data requirements to support the development of the MCC and MPMT.

---

#### 2.2.2 Reporting Catalogue

The Reporting Catalogue section seeks to:

- Specify the structure and classification for Migration reports.
- Identify reports timings and high-level content, and purpose.
- Provide an opportunity for stakeholders to offer feedback and opinions.
- Support a MCC Principle of continuous monitoring and improvement of the migration process.
- Present a core set of Migration Reports that can be iteratively enhanced during the active migration window.

We acknowledge that additional Migration insights and requirements may emerge through consultation and operational experience.

## 3 Objectives

The Migration Team aims to achieve the following objectives:

### 1. Identify Sources and Types of Data

Determine the data sources and other information including other Party reports that the MCC will need to Monitor, Manage and Control the MHHS migration.

### 2. Clarify Key Reports

Provide an overview of essential reports that parties can expect from the MCC, with key data items and expected frequency.

### 3. **Avoid Reporting Duplication**

Ensure that MCC reporting complements the MHHS Programme and does not result in duplication of effort or information where practical.

### 4. **Develop and Confirm Reports**

Once we establish the high-level report definitions, we will further refine the structure and data to assist parties in their planning and process development.

### 5. **Feedback and Adaptation**

Acknowledge that this list of reports is an important starting point and remains open to feedback to address additional requirements concerning data and frequency.

The Migration Team is committed to producing information that supports the Migration Framework principles and ensures clarity for all parties involved in the migration execution.

By collaborating with industry stakeholders, the team aims to create a reporting framework that meets the evolving needs of the MHHS migration processes.

## 4 Reporting Access and Roles

---

### 4.1 Overview

The MCC reporting framework has been structured to ensure controlled access to data based on predefined levels of reporting information.

These access levels are designed to safeguard commercially sensitive data while providing appropriate visibility to different stakeholders involved in the MHHS migration.

Each participant is assigned access based on the **MCC Role Code** and the associated **MPID**, ensuring access is specific to their organisation and relevant Market Role.

- Suppliers (Level 2) are granted access to their own submission data, including migration performance and schedules for their Supplier Group MPID.
- Agents (Level 3) access LDSO aggregated data filtered to include only their related Supplier MPIDs and-LDSO MPIDs.
- Higher-level participants (Level 4+), such as the MHHS Programme, Code Bodies, and Central Systems have progressively broader access, culminating in National Aggregate Data (Level 7).

## 4.2 Report Levels

The Report Information Levels below outlines seven levels of access, ranging from full data visibility for the MCC to aggregated data views for national reporting purposes. Each level is tailored to the specific needs of different participants, ensuring that they only access the data necessary for their role and responsibilities.

Report Level	Description	Information Available
1	MCC Access only	Full data access, including all migration and performance data.
2	Supplier Submission Data, Plans, and Migration Performance	Suppliers have access to their own data, including baselined schedules and migration performance for their Supplier Group MPID.
3	Agent-Related Supplier-LDSO Aggregate	Aggregate demand view, aggregate performance view. LDSO aggregated data is filtered to include only the confirmed Supplier Group MPIDs associated with the specific Agent MPID (provided by Supplier) <b>NOTE:</b> Suppliers are required to provide a list of Agents they have, along with their Market Roles, that the MCC will be allowed to share aggregated plan and outturn data with. <b>NOTE:</b> The MCC will report by Supplier Group MPID and therefore their relationship may be with an individual Supplier MPID within the Supplier Group MPID.
4	MHHS Programme, Code Bodies, Central Systems	<b>All LDSO</b> aggregated data for migration reporting and analysis.
5	Smart Meter LDSO Aggregate	<b>All LDSO</b> aggregated data with migration <b>outturn filtered specifically for Smart Meter</b> migrations.
6	LDSO Aggregate	Aggregated migration data specific to a given <b>LDSO MPID</b> .
7	National Aggregate	Fully aggregated national-level migration data.

## 4.3 Report Consumers

The Report Consumers table maps the MCC roles and DIP market roles to their respective report levels. By combining their MCC Role Code with the relevant MPID, participants are granted access to data at the appropriate level.
