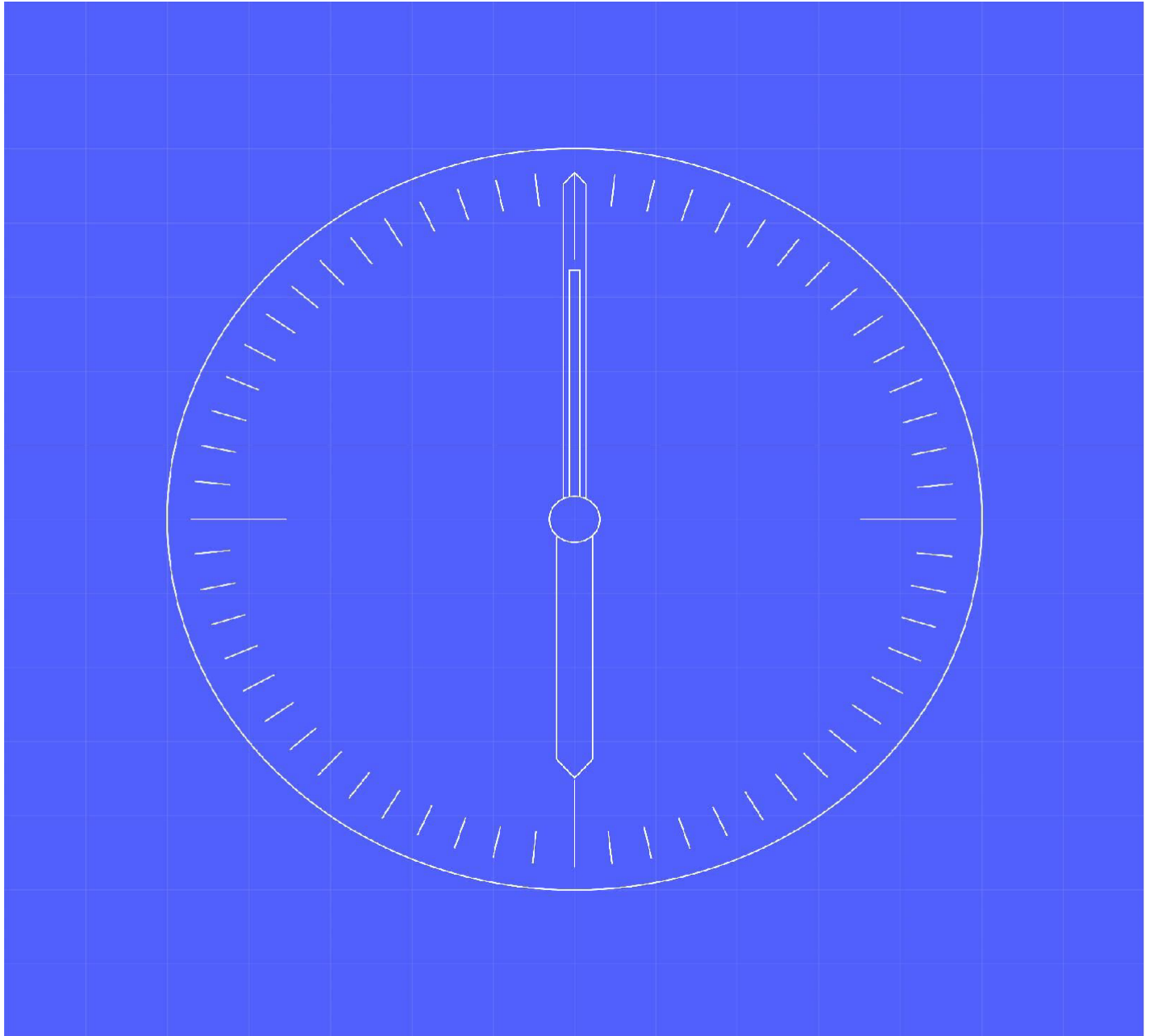

3.1 Shared Steps – Change to Approach

As part of the process of importing test cases to ADO for execution by PPs, we have had to merge Shared Steps into the parent test cases.

This presented a challenge, and risk, with regards to maintaining alignment across all platforms (Collaboration Base, MHHS Website and ADO – Test Management Tool).

The Programme has therefore used this update to also merge shared steps into parent test cases, on the Collaboration Base and MHHS website. This will greatly simplify navigation of the test cases for PPs who are still referencing the Collaboration Base or the MHHS website, as opposed to ADO.

Note therefore, that we have archived the Shared Steps files and sub-folders, so they will no longer appear in the Uplifts folders for themes and scenarios on the Collaboration Base or the MHHS Website.

The Baselined folders will still contain Shared Steps files for content that was approved at TMAG/SITAG.
