Why are we holding this webinar?

- To provide a demo of the Qualification Assessment Document (QAD) Portal that Programme Participants will be using during Qualification.
- We want to ensure that all Programme Participants are familiar with the functionality of the QAD Portal in preparation for submitting their initial and final QAD to the Code Bodies.



Why is the QAD important?

- Code Bodies expect Programme Participants to complete the QAD at an organisation level, covering all Market Roles they intend to
 operate within the new MHHS arrangements.
- To support the efficient review of evidence and to avoid unnecessary delay between the completion of Qualification Testing (QT) / MHHS
 Programme Systems Integration Testing (SIT) and MHHS Qualification being approved, evidence should be provided via an Initial QAD
 Submission and a Final QAD Submission.
- Code Bodies will then review this information and work with the Programme Participant to clarify and assure that the information provided meets Code Body requirements for MHHS Qualification.
