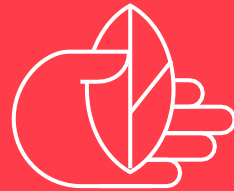

Today's session will focus on the contents of the **Submission Template folder** for those Suppliers who received Capacity Envelopes. We will walk through a worked example to help you understand the **Capacity Envelope** and to provide guidance on how to complete the **plan** submission:

In this session we will be walking through these files in the following order:
C, B, A, E and D.

Submission Template

A-Supplier Weekly Envelope and Plan Submission:

- Weekly envelopes for each LDSO where a Supplier has trading MPANs
- Suppliers provide their planned total submission for each week
- Indicates whether Envelope Submission Rules or De-minimis Submission Rules apply

B-Envelopes By LDSO / De-minimis by LDSO:

- MCC view of Supplier Portfolios of Trading MPANs by Envelope MPID and LDSO
- De-minimis LDSO Portfolios and de-minimis Supplier Portfolios in LDSO

C-Envelope MPID to Supplier MPID Map:

- Maps Envelope MPIDs to Supplier MPIDs where applicable

D-Supplier Contact List by Supplier MPID:

- Lists Supplier Contacts by Envelope MPID and Supplier MPID

E-Supplier Service Providers by Envelope MPID:

- Suppliers provide a list of expected MHHS Services Providers and percentage of portfolio by Envelope MPID

Field Names

To assist with understanding of the field names you can refer to the Guidance Document – MHHS-DEL2952 – Migration Supplier Envelope and Plan Submission Guide that can be found on both the [Collaboration Base](#) and [MHHS Website](#)

Requirement Type	Code	Description
Mandatory	M	Data must be provided
Optional	O	Data may be populated and helps aid understanding
Conditional	C	Based on certain business rules and/or the values of other data the item can become mandatory
Informational	I	Additional information provided by the MCC to assist in Supplier Submission.

- Industry ramp-up (Early Life Support Period)
- Supplier ramp-up period
- Core Migration window
- Period beyond core Migration window

INFO D – Supplier Envelope Portfolio by LDSO
